Application areas:

As an addition to Rhenocoll PVAC glues, such as Rhenocoll Standard, Extra, Spezial, Super W or Propellerleim. Used to prolong the open time. For professional use.

Advantages:

Thanks to the addition of Rhenocoll-Weißleimverzögerer VP 326 the open time of the glues can be increased to a maximum of 60 min. Therefore, glues with special water and temperature resistance - although these glues generally only allow very short open times - can be used for time-consuming glueing. Add only as much retarder as required by open time. Mixture can be stored for an unlimited time and adhesion or final durability do not change.

Technical conditions:

Addition quantity / open time (guidelines): An addition of max. 6% can increase the open time to a max. of up to 60 min.

The quantities added will result in varying open times, which have to be tested beforehand; depending on the type of glue, temperature and type of glueing, as well as type of wood.

The bonding times for wood elements will be increased significantly! Recommended is over night; however, you should conduct your own tests; bonding time is changeable depending on quantity added and mixture.

Storage: Cool, no danger of frost

General note:

When coating or painting the glued parts, test first, if a discoloration occurs when the joint area comes in touch with the coating. This can occur when using PUR lacquers, especially when PUR hardener or other isocyanates exist in excess.
